HOUSING MANAGEMENT & MAINTENANCE

- Mixed methodologies were utilised in the research: Online Survey & Telephone Interviews.
- Online Survey conducted by Edge Insight. The questionnaire link was sent out via targeted email & promoted via social media.
- Telephone interviews were conducted by BCC Telemarketing mirroring the Online Survey content & format in June 2024 amongst the audience of Housing Management & Maintenance to gauge progress in the sector, current thinking and approach and any obstacles delaying fire safety improvements
- 101 respondents participated in the survey.
- Respondents completing the Survey were offered entry into a Quarterly Prize Draw to win a £250
 Amazon voucher, while others were offered a £5 Amazon voucher. Individuals who selected to be
 part of the Housing Management & Maintenance Dedicated Research list were offered a £10 Amazon
 voucher.





Job Role



"How many rental properties do you or your company/association have in management?"






"Do you work on any housing that falls under the Fire Safety Regulations 2022 updates this year that require a Responsible Person?"


Frequency of Fire Assessments on Properties

How often do you or your association/organisation conduct fire risk assessments on each property under your company's remit




"How often on average would you say these assessments pass?"




Main Causes of Assessment Failures





Reasons Fire Risks Remaining Present



Responsibility for Rental Accommodation Fire Safety



"Who do you think the main onus should be on rental accommodation fire safety?"



In your experience, do 'better' fire safety products significantly reduce fire risk





Trust in Product Manufacturers



Experience of Reporting Fire Safety Issues or Malpractice








Improvement in Fire Safety in Last 5 Years

"In the last 5 years, how would you rate the improvement of fire safety in the following areas?"



What percentage of the housing you've worked on in the last 6 months would you estimate has unsafe cladding?








